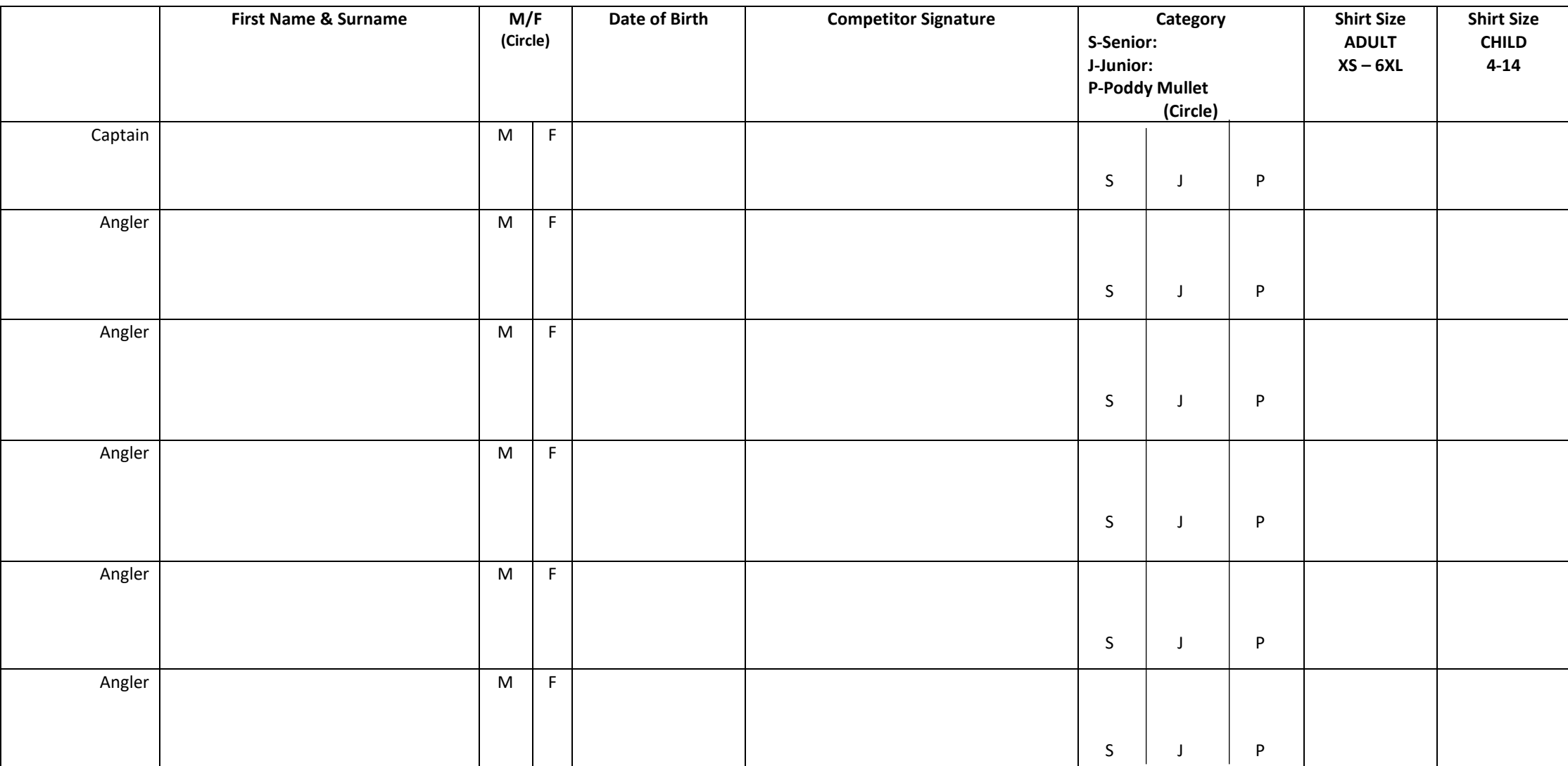
### CONDITIONS OF ENTRY

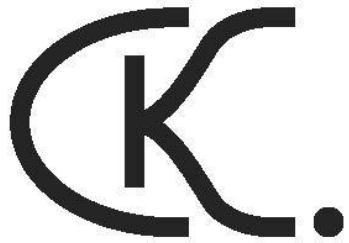
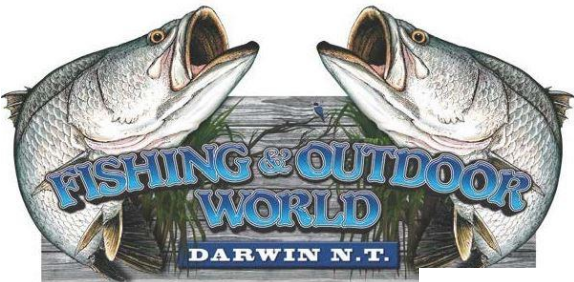

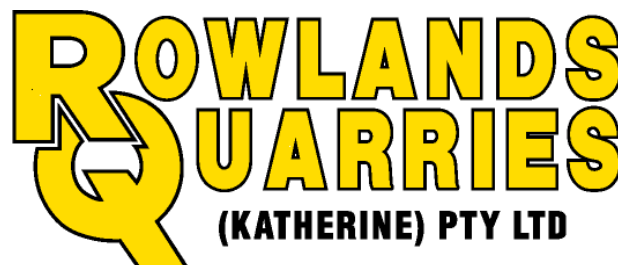
